- All bids are to be submitted in the name of the Chief Administrative Officer, IIM Nagpur only. Bid shall not address to the Director, IIM Nagpur will not be opened & rejected summarily.
- 2) The Vendor shall submit a work order for similar kind of work.
- 3) Vendor shall file application for authorization and consent to Operate/renewal from MPCB.
- Vendor shall liaison with MPCB and visits to head office of MPCB Mumbai/ Nagpur office if required.
- 5) The total fees inclusive of travelling expenses, staying and all other expenses.
- 6) The statutory fees will be borne by IIM Nagpur as per the actual online demand/invoice produce from the MPCB.
- 7) The selected vendor shall coordinate to IIM Nagpur for providing required documents for filling of online application to MPCB PORTAL for obtaining Consent to Operate
- 8) Vendor shall reply all queries raised by MPCB Nagpur/Mumbai office and handle compliance for the same.
- 9) Vendor shall coordinate with MPCB during course of 2 years for compliance of General Condition of MPCB.
- 10) The 90% payment shall be released on receipt of obtaining consent to operate under red category from Maharashtra Pollution Control Board for 2 years and balanced 10% of the payment will be released on completion of two years renewal period.
- 11) Liquidated damages charges: In the event of not carrying out work, Liquidity Damages Charges will be deducted to the sum of 0.5% of the contract price of the delayed /undelivered, stores/services mentioned above for every week of delay or part their of a week, subject to the maximum value of the Liquidated Damages being not higher that 10% of the value of delayed stores.
- 12) Bank details such as Account Number, IFSC code, etc. should be furnished so as to facilitate payment online if any.
- 13) Time Period for provision of obtaining consent to operate: 45 days from the date of issue of the work order OR date of approval by the Engineer in charge (Whichever is later). Extendable for reasons beyond the contractor's control and upon Engineer's recommendation
- 14) Interested parties should submit their bid through hard copy in Project Manager office, Estate and Maintenance Department of IIM Nagpur subscribing "Tender document for Consultancy service for Obtaining consent to operate under red

category from Maharashtra Pollution Control Board for 2 years at IIM Nagpur" on or before 01 March 2023 before 15.00 hours which will be opened on 1st March 2023 at 15.30 hrs.

- 15) Agency should submit the "Annexures A, B & C duly filled-in and signed.
- 16) The work will be awarded to the lowest (L1) eligible consultant.

INSTRUCTIONS FOR SUBMISSION OF BIDS

- 1. The price bids of only those bidders shall be considered for evaluation whose bid is determined to be technically acceptable to IIMN.
- 2. Price Bid submitted only in the given format will be accepted.
- 3. Any conditions/terms given in the bid by bidders on their own shall not be binding on the IIMN. All the terms & conditions will be as given herein, and no change in any terms or conditions by the bidders will be acceptable.
- 4. Bidder signing the tender form or any other documents forming part of the contract on behalf of the Bidder shall be deemed to warranty that he has authority to bind the Bidder. If subsequently comes to light that the person so signed had no authority to do so, the IIMN may, without prejudice to any other civil & criminal remedies, cancel the tender and hold the Bidder liable for all costs, charges, and damages.
- 5. In case of any dispute, The Director, IIMN, shall be the sole arbitrator, and his decision shall be final & binding on both parties.
- 6. Any bid received by IIMN after the deadline for submission of bids prescribed by the IIMN shall be rejected and returned unopened to the bidder.
- 7. Any cutting/overwriting etc., in the tender must be signed by the person who is signing the tender. The rates and units shall not be overwritten. The financial part of the bid shall always be both in figures and words. In case of discrepancy in words or figures, the amount least between the figure and word will be treated as final.
- 8. The bidders have to submit the price bid only as per the price schedule format given above in this tender document. Any other format for submission of price bid shall be out rightly rejected without any further reference to the bidders.
