The bidder has to fill the price in the Price bid format downloaded from IIMN website only. The prices shall be filled both in figures and in words and the total amount shall be calculated and rounded off to the nearest rupee. No overwriting or use of correction fluid shall be accepted. Any correction shall be legible and signed by the authorised signatory.		

The tender shall be submitted in two parts, viz., technical bid and price bid. The offers submitted by Fax/email shall not be considered. No correspondence will be entertained in this matter.

Part II: Price Bid

Price Bid of only technically qualified bidders shall be opened at later date in presence of authorized representatives of bidders & IIMN Officers. Technically qualified bidders shall be intimated by web notification and or email. The date, time and location of opening the price bid shall be communicated to the eligible bidders.

- The service provider shall quote the rates for each building basis for 6 months interval validity of Form B, however the same rates shall be applicable for next tenure of renewal FORM B for applicable period of service contract.
- The rates quoted shall remain firm throughout the tenure of the service contract as well as in case of extension of contract as mentioned above and no revision is permissible for any reason.
- In case if the price bid is found to be tempered/modified in any manner, tender will be completely rejected and bidder is liable to be banned from doing business with IIMN.
- Do not quote price in the Technical Bid i.e. in Part-I or elsewhere which would lead to bid getting disqualified without any further reference to the bidders.
- The prices must include all the applicable taxes and duties, fees and any other charges except GST. GST component if applicable to be shown separately and will be paid extra, if applicable.
- IIMN reserves the right to negotiate the quoted price with the successful bidder.

Other Terms & Conditions:

- 1) The service provider needs to submit FORM B in prescribed format issued by Maharashtra Fire Services and valid license issued by Maharashtra Fire Services twice in a year.
- 2) It is the sole responsibility of the service provider to liason and provide assistance during inspection of fire extinguishing and fire protection services at the institute campus by Chief Fire Officer/Deputy Chief Fire Officer/Nominated officer from Maharashtra Fire Services/Maharashtra Airport Development Corporation (MADC), Nagpur for renewal of fire fitness certificate of all establishments and keeping FORM B valid for the complete validity period.
- 3) The final payment to the service provider shall be done only after complete approval of FORM B from Chief Fire Officer/Nominated Officer from Maharashtra Fire Services/Maharashtra Airport Development Corporation (MADC), Nagpur and renewal of fire fitness certificate from the same.
- 4) The bidder may inspect the site before quoting the rates.
- 5) The service provider shall issue the FORM B within 2 days after testing/trial of fire protection system of all buildings.
- 6) The number of buildings may increase or decrease during the service contract period depending on decision of IIM Nagpur, but the rates shall not be revised and the payment will be done after issue of FORM B on each building basis only.
- 7) The name of bidding firm and the name of firm mentioned on license shall be same, the partnership firm or other firm is not allowed to participate in place of licensed firm.
